- □ In Indonesia, drought and flood disaster and water pollution have reached the critical level
- Water resources is the most important element of natural resources for the survival of humanity and ecosystem
- Integrated effort are required within a national frame work by all stake holders, in order to overcome the critical situation to achieve the people welfare and sustainable development

WATER FORUM

- Indonesia has conducted Indonesia Water Forum I (IWF I) in November 2000, followed by Water Forum II (IWF II) in March 2002
- IWF I had achieved a common perception in water resources management :
 - (-) Vision : efficient and sustainable water management and use for the welfare of the people
 - (-) Commitment : government policy reform in water resources development

WATER FORUM

- Establishment of Indonesia Water Partnership (IWP) and nominated nine representatives from stake holders to establish IWP Secretariat.
- Recommendation on policy and strategy for flood mitigation and management
 IWF II come to a declaration of two important statements.

STATEMENTS

- IWF is a periodic meeting amongst public, sector, private sector and the community to achieve policy on sustainable water resources development
- IWF is a net working amongst public sector, private sector and the community which agreed to support the implementation of IWRM
- IWP Secretariat is a working unit which is established by representative of water resources stake holders
- IWRM is a process which promotes the coordinated management of water resources to maximize the resulting welfare in equitable manner without compromising the sustainability of ecosystem

VISION AND MISSION

Vision of IWP is an efficient and sustainable water management and use for the welfare of the people

Mission : to support the government, private sector and community in implementing the Integrated Water Resources Management at national, provincial, river basin and district/ municipal level.

Frame work :

Management instrument or tools which are needed to replace the way water resources are managed and use

WORK MECHANISM

- Indonesia will conduct IWF periodically as a summit meeting to discuss any issues related to water resources management and committed to realize as part of programs of each stake holders
- IWP will become a focal point to communicate with international and regional water institutions such as GWP, GWP-SEATAC, IWMI, INPIM, NARBO, ICID, ICOLD
- IWP will also establish relation with water stake holders at provincial, river basin and district/municipal level by promoting the establishment of provincial and local water partnership
