



# ISSUES AND OBSERVATIONS



## Issue: Improper management of Sand Mining

#### Environmental issues observed:

• River bed lowering resulting to low water table which affects water wells and agriculture (as stated by the sand miners)

• River bank erosion (direct observation)

•Sand miners aware of the environmental problem created but have no alternative for livelihood

#### Organizations involved

• Pradesiya Sawa was responsible for issuing permits but recently it is taken by central government (district / divisional secretariat)

- No NGOs or Sand Miners Union exists
- Permits are issued to contractors/agencies and they employ (uncontrolled) labours

#### Participation and Coordination

- No/less representation of local institutions
- No coordination between district/division and Pradesiya Sawa in issuing permits
- No monitoring mechanism except some police actions

## Issue: Water pollution due to elephant bathing

#### Environmental issues observed:

- Bathing of more than 70 elephants 2 hours twice daily (direct observation)
- During low flow, water pollution occurs (as per the guide)
- Skin disease due to water pollution (as per member, Pradesiya Sawa of Rambukkanna)
- Water is polluted more due to industrial pollution than elephant bathing (as per environmental officer, Pradesiya Sawa of Rambukkanna)
- Water quality is not monitored to provide scientific evidence of skin diseases (as per medical officer, Division Secretariat)

#### Organizations involved

- Provincial Government, Central Government
- •Ceylon Tourism Board, Hotel Association of Ceylon
- •Pressure groups like Shrama Shakti Foundation / Lanka Jalani

#### Participation and Coordination

- Less participation of local stakeholders
- Major decisions taken by the central government

• Good coordination between government and tourist board and less coordination with local communities

### Issue: Solid Waste Disposal on River Banks

#### Environmental issues observed:

• Small amount of construction waste dumped on the road side

#### Organizations involved

- Responsibility is mandated to Pradesiya Sawa, however, due to the lack of budget it could not be implemented
- •Pradesiya Sawa members claim that this issue is the responsibility of Health Department
- No NGO is working in this sector

Participation and Coordination

• No observations made

## Issue: Quality of Water

#### Environmental issues observed:

- Water from river is treated for drinking purpose (as per divisional secretariat members)
- The quality of tap water is not good so people prefer wells for drinking purpose (as per the environmental officer, Pradesiya Sawa of Rambukkanna)
- No scientific data available for the quality of water

#### Organizations involved

- Hiriwaduwa water purification plant
- Council

#### Participation and Coordination

- Do not have monitoring mechanism
- •No coordination between health and environment department
