


## Review 1 (typical issues 1)

- Organizational issues
  Lack of coordination among water-related agencies,
  RBO related issues
- Legal issues
  Water rights issue, Lack of basic water law
- Other Administrative issues
  Lack of Basin planning



## Review (example of proposal 1)

- Concerning the lack of coordination among agencies
  - (1) Clarification of the mandate of the water-related organizations, and promotion of RBO establishment (Vie)
  - (2) Review of mandates, roles and responsibilities, plans and programs (Phi)
  - (3) Establishment of Apex Body (national level), and coordination body at the basin level (Ind)
  - (4) Capacity building and strengthening institutional framework; developing human resources; raising awareness and perusing participatory approach (Lao)

#### Review (example of proposal 2)

- Concerning the water rights issues
  - (1) Preparation for guidelines for water rights (Vie)
  - (2) Education and information campaign (Phi)
  - (3) Strict implementation of law (Phi)
  - (4) Establishment of RBO (Phi)
  - (5) Formulate and implement Raw Water Pricing Policy (Phi)

## Review (example of proposal 3)

- Concerning the issues on basin planning
  - (1) Establishment of mechanisms to synchronize plans, programs and activities of agencies and organizations (Phi)
  - (2) Development of water resources master plan for Sri Lanka for next 25 years (Sri)
  - (3) Should assess the process to prepare the river basin planning (Lao)

#### Review (example of proposal 4)

- Data management
  - (1) Collection of water uses data at the community level for sharing between public and people sector (Thi)
  - (2) Improved investment in advanced technology, equipment, technical science in order to facilitate to calculate, design and implement water resources management process (Vie)

## Important point (1)

- In order to realize your proposal, what will be your organization able to do? Please consider this point.

  "What my organization will do for realizing the proposal"

## Important point (2)

- Your proposals are feasible?
- We don't require to achieve big goals. The action plan should be feasible, taking the status of your organization into consideration.
