The Situation about the dissemination (4: Organization)

- 1. The well-implemented concept of recovery cost by increase the water tariff and hydropower is still difficult to be achieved.
- 2. Public services activities needs supported fund immediately, Central Government contribution is totally required.
- 3. Sharing of cost between public services and business still in process and become a first priority.
